Background

The Meghalaya Basin Management Agency (MBMA), which is a non-profit company, incorporated under the Planning Department, Government of Meghalaya is selected as implementing agency for implementing *the Cluster Development Programme – Turmeric cluster in West Jaintia Hills, Meghalaya*. MBMA will implement **Integrated Verticals i.e.**

- (i) **Pre-production & Production,**
- (ii) **Post Harvest Management and Value addition and**
- (iii) **Logistics, Marketing and branding** with Turmeric as focus crop

Lakadong Turmeric which is known as one of the finest turmeric varieties in the world with a curcumin content of more than 7% (almost 2% higher than other varieties), has been grown in the district for many generations. It is very much sought after for use in the cosmetic, pharmaceutical and food industry. However despite this good demand, farmers have not, till date, been able to realize the full economic potential of this crop primarily because of the small volume of production, preponderance of small and marginal farmers, absence of focused research, low individual volumes exacerbated by lack of organized aggregation, weak post-harvest management and market facilities, lack of universal access to information, skills and technology, unreliable price discovery, dominance of middle men, trader cartelization, access to finance and most importantly, insufficient quality planting material in Lakadong Turmeric. Farming families of the Jaintia Hills have been preserving and multiplying Lakadong mother plants for many generations but of late the decline and non-availability of quality mother rhizomes is a growing cause for concern.

4. The quotation should be accompanied by:
 - (i) A Copy of your business registration/ trading license
 - (ii) A copy of the Authorized dealership certificate; if applicable
 - (iii) A copy of GST Registration certificate
 - (iv) Self-declaration to the effect the bidder is not insolvent, in receivership, bankrupt or being wound up or subject to legal proceedings for any of these circumstances.
 - (v) Self-declaration that the bidder's business activities are not suspended or debarred from public procurement by the State Government of Meghalaya or Government of India.
 - (vi) Complete price and delivery schedule
 - (vii) List of priced accessories which are not included in the Goods prices.

Adequate technical documentation and catalogue(s) and any other relevant information.

5. The deadline for receipt of your sealed quotation is 27th February, 2026 by 3:00 PM. Quotations will be opened on 27th February, 2026 at 3:30 PM. Late quotes will be rejected.

6. All requests for clarifications shall be submitted via email to cdpprocurement.mbma@gmail.com on 16th February, 2026 by 4:00 PM, The purchaser shall respond to all requests for clarifications by: 18th February, 2026 by 4:00 PM.

7. Quotations should be submitted in physical form (hard copy) either by hand or by post/courier by the deadline and to the address stated above.

8. Bidders have to quote for all items, however, all items mentioned in the offered lot must be quoted. A partial quote for the respective Lots will not be accepted. If a quotation shows Goods listed but not priced, their prices shall be assumed to be included in the prices of other items. An item not listed in the quotation shall be assumed not to be included in the quotation.

9. **Evaluation.** The purchaser shall award the contract to the bidder whose offer has been determined to be the lowest priced quotation. The financial evaluation will be based on the total amount quoted for all items. If two or more bidders submit identical bid amounts, the contract will be awarded to all such bidders by dividing the quantity equally among them. If any of these bidders decline to accept a partial supply, the successful bidder will be selected through a draw of lots.

10. **Delivery schedule. (as per Incoterms 2010)** The Goods are required to be delivered within the time as specified in the delivery schedule. Quotations offering delivery beyond this delivery time shall be treated as non-responsive.

(a) **Prices.** Prices shall be in INR (Indian Rupees).

(b) **Availability of After sales services:** Not Applicable

11. **Payment.** Within 30 days after delivery and acceptance of goods/service.

12. **Delivery:** To be delivered in Shillong at the O/o The Meghalaya Basin Management Agency Procurement Division (CDP) C/o Meghalaya State Housing Financing & Cooperative Society, Upper Nongrim Hills, Shillong, Meghalaya, India – 793003.

13. **Delivery Schedule:** All items should be delivered within 30 days after signature of the contract. Bidders must state an exact delivery time in the quotation.

14. **Brand:** as per mention at details specification

15. **Validity.** Your quotation should be valid for a period of 60 days from the date of your quotation.

16. **Purchase Order.** The purchase order shall be issued by the Meghalaya Basin Management Agency before the end of the validity of the quotation to the eligible bidder who submitted the lowest evaluated quotation for the evaluated lot. Prior to the issuance of the purchase order and after the completion of the evaluation process, the purchaser reserves the right to increase or decrease the requested quantities under this RFQ. The maximum increase allowed to be done to the quotation prior to purchase order signature is +15% and the maximum decrease is -15%.
